### Biodiversity, Hunting and Countryside Intergroup

The Biodiversity, Hunting & Countryside Intergroup was created in 1985 and is one of the oldest and most active parliamentary platforms. It gathers MEPs from different political groups and various stakeholders promoting wildlife conservation, sustainable hunting and fishing, as well as the sustainable management of the countryside and cultural heritage.

The objective of the Intergroup is to promote the role of hunting and other forms of sustainable use of wild species for biodiversity, wildlife management, rural development and forestry issues. Additionally, the Intergroup regularly focuses on cross cutting issues that affect socio-economic activities in rural areas and seek to build bridges between the civil society and decision makers.

Past debates and discussions have, addressed issues such as forestry management, wildlife population, the future of European water courses, the 2020 EU Biodiversity Strategy and other topics related to Natura 2000.

For the term 2014-2019, the Intergroup has been validated by European Parliament Conference of the Presidents and named the "Biodiversity, Hunting and Countryside Intergroup".

FACE (Federation of Associations for Hunting and Conservation of the EU) provides the Secretariat for the Intergroup since 1985. In 2004, the ELO (European Landowners' Organization) joined the Intergroup as Co-Secretariat, bringing expertise in countryside-related topics.

**Vladimir URUTCHEV** is a nuclear power engineer with an interest in all forms of clean energy. As part of the World Association of Nuclear Operators (WANO) and the International Atomic Energy Agency (IAEA) he took part in several peer reviews on the safety of nuclear power plants worldwide. He is a devoted environmentalist, which sparked his interest to support environmentally sensitive agricultural

developments. He is a leading supporter of the Agripreneur initiative in Bulgaria to combine the best of rural heritage with the opportunities of modern agri-environmental practices. Vladimir Urutchev is a Member of both the Committee on Industry, Research and Energy (ITRE) and the Committee on Agriculture and Rural Development (AGRI) of the European Parliament and is Vice-President of the European Energy Forum. Mr. Urutchev is the EPP Shadow Rapporteur on the INI Report "State of play of farmland concentration in the EU: how to facilitate the access to land for farmers".



**Thomas WIEDMANN** is an official of the European Commission since 2005. He works as a legal officer in the Commission's Directorate General for Financial Stability, Financial Services and Capital Market Union.

Since 2011, he is dealing with investment issues in the unit responsible for the free movement of capital. Prior to entering the European

Commission, Thomas Wiedmann has held various functions in the German judiciary service, inter alia; he was a judge at the Superior Court of Stuttgart (Landgericht) in civil law matters. He began his career in the ministry administration of the German land of Baden-Württemberg, serving in the state chancellery as well as in the offices of Bonn and Berlin. Mr Wiedmann studied law at the universities of Tübingen and Paris (Paris 2, Pantheon-Assas). He specialised in comparative law (PhD in 1996) and European law. He is the author of numerous publications on European law and public comparative law.
